Lead Auditor Training for General Manufacturing Quality Management Systems

The ISO 9001: 2015 standards as a foundation, building on additional regulatory requirements and notations pertaining to general manufacturing needs. Even though ISO 9001:2015 is used as the model for teaching systems and audit, this course enables students to develop and apply auditing skills using any applicable management system standard. Apex QA with QMII is continuing to offer courses that cover the ISO 9001:2015 requirements. QMII is an Exemplar Global Certified TPECS provider for Exemplar Global QM, AU, and TL Competency Units.

This 4-day course has been developed to satisfy the Exemplar Global QM, and AU Examination Profiles and, as such, all attendees who successfully pass the exams during this course will achieve a Certificate of Attainment for the following competency units:

Group exercises and case studies with examples from the aerospace industry will be used to develop the required auditing skills.

The auditing guidelines —including the auditing process and methodologies, e. g., planning and conducting an audit, writing nonconformity statements, preparing an audit summary and report, and verifying corrective actions—and their application in the aerospace process approach are covered. Auditing case studies from the aerospace industry to develop skills for identifying nonconformities will be used. Techniques for leading audit teams will also be discussed.






Who Should Attend
